## Feis Ceoil Association - Child Safeguarding Statement

Feis Ceoil Association promotes the cultivation and advancement of the musical arts in Ireland, especially among the young. We organise and promote an annual Music Festival consisting of competitions and concerts to provide a forum for international benchmarking, constructive criticism and general encouragement to all who participate.

Feis Ceoil Association acknowledges a duty of care to safeguard and promote the welfare of children and is committed to ensuring that its safeguarding practice reflects statutory responsibilities, government guidelines and complies with best practice.

In accordance with the requirements of the Children First Act 2015, Children First: National Guidance for the Protection and Welfare of Children 2017, and Túsla Guidance on the preparation of Child Safeguarding Statements, the Board of Feis Ceoil Association has agreed the Child Safeguarding Statement as set out in this document.

### ***We recognise that:***

1. The welfare of the child/young person is paramount
2. All children regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity, have the right to equal protection from all types of harm or abuse
3. All children must be protected from abuse whilst attending any events organised by Feis Ceoil Association

### ***As part of our safeguarding policy Feis Ceoil Association will:***

- Promote and prioritise the safety and wellbeing of children and young people
- Fully comply with its statutory obligations under the Children First Act 2015 and other relevant legislation relating to the protection and welfare of children
- Fully co-operate with the relevant statutory authorities in relation to child protection and welfare matters
- Adopt safe practices to minimise the possibility of harm or accidents happening to children and protect staff and volunteers from the necessity to take unnecessary risks that may leave themselves open to accusations of abuse or neglect
- Review specific staff and volunteer roles to identify child protection and welfare concerns
- Ensure everyone understands their roles and responsibilities in respect of safeguarding and is provided with appropriate learning opportunities to recognise, identify and respond to signs of abuse, neglect and other safeguarding concerns relating to children and young people
- Ensure appropriate action is taken in the event of incidents/concerns of abuse and provide support to the individual/s who raise or disclose the concern
- Ensure that confidential, detailed and accurate records of safeguarding concerns are maintained and securely stored
- Ensure careful recruitment of staff and volunteers, which shall include the taking up of references for new recruits, conscientious interviewing, training and ongoing supervision and management

# Feis Ceoil

The policy and procedures will be widely promoted and are mandatory for everyone involved with Feis Ceoil Association. Failure to comply with the policy and procedures will be addressed without delay and may result in exclusion from the organisation.

## Risk Assessment

We have carried out an assessment for any potential risk for harm to a child while engaged with Feis Ceoil Association. Feis Ceoil's activities comprise attendance at competition and attendance and/or performing at concerts organised by the Association. Below is a list of the areas of risk identified and the list of procedures for managing these risks.

Risks Identified	Procedures in place to manage risks identified
Large groups of children attending competitions (i.e. Choirs/orchestras)	<ul style="list-style-type: none"> <li>• Minimum ratio of adult supervisors to children (1:12), as specified in Feis Ceoil Regulations</li> <li>• Children First training for all staff/volunteers</li> </ul>
Attending competitions/concerts	<ul style="list-style-type: none"> <li>• Children First training for all staff</li> <li>• Competition Steward(s) in attendance at all competitions</li> </ul>
Use of video/photography/other media to record activities	<ul style="list-style-type: none"> <li>• Only professional photographers/videographers engaged by Feis Ceoil are permitted to take photographs or videos during our events. Necessary permission <b>must</b> be sought from the primary carer.</li> <li>• Each venue displays signage prohibiting photography or recording by the general public.</li> </ul>
Travel between Feis venues	<ul style="list-style-type: none"> <li>• Children and vulnerable adults must be supervised at all times by their primary carers</li> </ul>
Practising in warm-up rooms	<ul style="list-style-type: none"> <li>• Children First trained staff are on site to monitor warm-up rooms</li> <li>• Primary carers accompany children while warming up</li> </ul>

## Procedures

In addition to the procedures listed in our risk assessment, the following procedures support our intention to safeguard children while engaged with our organisation.

1. Code of Behaviour for staff and volunteers
2. Procedure for dealing with incidents and accidents
3. Procedure for dealing with complaints concerning safeguarding
4. Procedure for reporting issues relating to child safeguarding
5. Procedure for maintaining confidentiality

## Implementation

We recognise that implementation is an ongoing process. We are committed to the implementation of this Child Safeguarding Statement and the procedures that support our assurance to keep children safe from harm while engaged with Feis Ceoil Association.
